Once referral is made, appointment with clinician is in 3 or 4 days or sooner if available for an assessment; then an APRN appointment is given for 2-3 days from then or sooner if available

Clients must be in therapy weekly to engage with med providers. Adults must have a primary mental health diagnosis (per licensing regulations). Time from intake to seeing a prescriber is approximately 5-6 weeks and includes being seen for individual therapy at least 3 times.

The majority of clients are Medicaid, Medicare or uninsured.
